C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The project water site is depicted as an intermittent river on the USGS topographic map for San Juan, SE-Texas. The relatively permanent water is within the 100 year flood plain and is labeled by FEMA maps as in the Main Floodway. Based on aerial photography from Microsoft live maps and Google Earth imagery, there is a direct hydrologic connection between the project waters and another RPW, the Llano Grande Lake. The Llano Grande lake is then directly connected to the Arroyo Colorado, which at this point is a RPW, but becomes a Traditionally Navigable Water further downstream at Harlingen, Texas. The aerials also depict the proposed site holding water continuously through the connections of the proposed site, Llano Grande Lake and the Arroyo Colorado. The applicant describe the tributary as always containing water as well because the tributary is used for irrigation runoff. Based on the flow regime, vegetation, and historical soil survey maps the RPW is a natural creek that is now used for drainage, and is labeled as a drain ditch by Hidalgo County. The RPW is not leveed or man-made.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands.
