C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

This section of the river is approximately 37 river miles long. One representative operated the 1982, 14-foot, double-wide commercial grade MonArk Jon-Boat (flat-bottomed & squared bow) equipped with a 15 HP Yamaha Outboard Motor. The boat was launched just under the Highway 359 Bridge on the Nueces River near Mathis, Texas at 7:45. The boat was removed from the Nueces River at the Calallen Salt Water Barrier Dam near Calallen, Texas at 17:00. Furthermore, there is currently a permit application in this office wherein the County of San Patricio is proposing to construct a boat ramp at La Fruta Park which is located below the Wesley Seale Dam and upstream of this location. It is the conclusion of the Corpus Christi Regulatory Field Office that this section of the Nueces River is navigable-in-fact as it applies to jurisdiction under Section 404 of the Clean Water Act. (See attached memo)

B. ADDITIONAL COMMENTS TO SUPPORT JD: 33 CFR Part 328.3 describes adjacent as "bordering, contiguous, or neighboring" and does not require a surface connection to establish adjacency. Galveston District policy # 01-001, dated 13 February 2001 states, "Proximity is the physical closeness of a water to a navigable water..." and "If a wetland/water...is separated from other waters of the US by a man-made dike or barrier, natural river berm, or beach dune, it is 'adjacent'." Proximity must be considered in conjunction with the hydrological connection. Section (b) Hydrological Connections: of the aforementioned policy states "relationships between (a wetland and a) navigable water, or a surface tributary system, must exist to be considered adjacent." C. SIGNIFICANT NEXUS DETERMINATION
